#### Tribal Maternal, Infant, & Early Childhood Home Visiting Program

Naytlh - 'a "We Carry the Children"



Our home visiting program provides parenting and life skills for successful and positive parenting. We serve native families that are either expecting or have infants under the age of twelve months, continuing through the child's third birthday. We travel throughout the 11 county service areas of the Confederated Tribe of Siletz Indians. The model and curriculum we provide is called Family Spirit and was developed by the John Hopkins Center for American Indian Health. We are funded by the Tribal Maternal, Infant, Early Childhood Home Visiting Program (TMIECHV).

Family Spirit is Evidence based and culturally sensitive to native families. Parents gain knowledge and skills for their developing infant through 36 months of age. We also focus on goals and healthy living for parents as a support system for the family as a whole. The program consists of 63 lessons over a 39 month period and is divided into six modules. The modules are broken into these categories: Prenatal care (9 lessons), infant care (16 lessons), your growing child (11 lessons), toddler care (9 lessons), my family and me (6 lessons), and healthy living (12 lessons). While this may seem like a big commitment the lessons vary from 30 minutes to 90 minutes and some can be combined together as we work with your schedule. Family Spirit suggests we deliverer at least 32 lessons to our families in order for families to benefit from the evidence based curriculum. For the full benefits of the program we would like to provide all 63 to our families. As a thank you for participating in our program we offer some incentives which we will be happy to share with you upon the enrolled in our program.

During your participation if you feel like the timeline of lessons is too often we can adjust the home visits to accommodate your schedule while still keeping the programs timeline in mind. We are a voluntary program that delivers home visits in the comfort of the homes of our families. If you would like to get more information and or meet our home visiting staff would love to schedule a home visit to give you a full overview of the program.



**CRT** services are available for Vocational Training, GED completion, a term of Higher Ed.

#### **Direct Placement**

**DP** is available to any tribal member who has obtained full time employment and applies within seven days of the hire date. Service provides clothing and tools necessary for work.

#### **On-the-Job Training (OJT)**

**OJT** is available to any tribal member seeking employment. It is a reimbursement to an employer for half of a hired employee's wages, up to \$4,500.00 or 6 months, whichever comes first.

#### Work Experience (WEX)

**WEX** can be used to obtain current training and skills to be a valued employee. 480 hours paid at minimum wage.

Come learn how to smoke fish at home --- safely! Learn how to cut up a piece of fish, prepare a brine, and smoke the fish in an electric smoker.

A small chunk of salmon and all supplies will be provided.

The brined fish will be refrigerated overnight.

The following day you can come back and smoke your fish.

Smoking fish can take up to 6 hours in a smoker.

#### Car Seat Recommendations for Children

#### "Best Practice" for Safer Travel

Children should ride properly restrained on every trip in every type of transportation.

- Infants and toddlers under 2 years of age should ride in a rear facing car seat.
- Toddlers should ride in a forward-facing car seat only after they outgrow the rear facing limits on the car seat.
- Older children should ride in a belt-positioning booster seat after they outgrow the harness on the car seat.
- All children should ride in the back seat until they are 13 years old.
- All passengers should be safely restrained in a lap and shoulder safety belt.

Parents often look forward to transitioning from one stage to the next, but these transitions should generally be delayed until they are necessary - when the child outgrows the limits for their current stage.

#### Additional Safety Tips

Rear Facing: Never place a rear facing child in front of an active frontal air bag.

Forward Facing: Use the top tether when the anchor is available or have an anchor installed.

Booster: Have your older child use a booster seat until the lap and shoulder belt fit properly – even if age 8 or older or taller than 4'9" in height.

Attend a check-up event or meet with a Child Passenger Safety (CPS) Technician to make sure children are riding safely. Call or visit www.childsafetyseat.org for a calendar of check-up events. Refer to the child safety seat manufacturer's manual and the car seat information in your vehicle owner's manual for specific details.



#### When is my child ready to ride in a safety belt?

- 1. Is the child tall enough to sit with their back against the vehicle seat back?
- 2. Do the child's knees bend comfortably at the edge of the vehicle seat?
- 3. Does the belt cross the shoulder over the collarbone?
- 4. Is the lap belt low, touching the thighs?
- 5. Can the child stay seated like this for the entire trip?
- A "No" answer means the child should continue riding in a booster seat for best protection.

#### Oregon Occupant Protection Laws

**Child Restraints:** Child passengers must be restrained in approved child safety seats until they weigh 40 pounds or reach the upper weight limit for the car seat in use. Infants must ride rear facing until they reach two years of age.

**Booster Seats:** Children over 40 pounds **and** who have reached the upper weight limit of their car seat's harness system, must use a booster seat until they are 4'9" tall **and** age 8.

Safety Belts: A child taller than 4'9" and age 8 or older must be properly secured with the vehicle's safety belt. The child is properly secured if the lap belt is positioned low across the thighs and the shoulder belt is positioned over the collarbone and away from the neck.

Failure to properly use safety belts or child restraints is a Class D traffic violation with a \$110.00 fine. (ORS 811.210 and ORS 815.055, effective January 1, 2012.)





#### **April is National Distracted Driving Awareness Month**

#### Pay attention, save a life: Ditch the distractions

More than 80 percent of people say they feel uncomfortable riding with a distracted driver. ODOT and partner agencies, Oregon State Police and AAA Oregon are emphasizing the importance of focusing on driving when you're behind the wheel.

#### Ditch the distractions:

- 1. **Turn off your cell phone and stow it.** Turn your phone off or switch to silent mode before you get in the car. Then stow it away where it's out of reach.
- 2. **Spread the word.** Record a message on your phone that tells callers you're driving and will get back to them when you're off the road.
- 3. **Install an app.** Apps can help you avoid texting while driving. Go to your app store and search for "distracted driving."
- 4. Pull over. If you need to make a call, pull over to a safe area first.
- 5. Use your passengers. Ask a passenger to make the call or respond to a text for you.
- 6. **X the text.** Don't ever text and drive, browse online or read your email while driving. It's dangerous and against the law in most states. Even voice-to-text isn't risk free.
- 7. **Know the law.** Familiarize yourself with the state and local laws before you get in the car. Oregon prohibits the use of hand-held cell phones in addition to texting.
- 8. **Prepare.** If using a GPS device, enter your destination before you start to drive. If you prefer a map or written directions, review them in advance. If you need help while driving, ask a passenger to assist you or pull over to a safe location to review your map.
- 9. Secure your pets. Unsecured pets can be a big distraction in the car.
- 10. Mind the kids. Pull over to a safe place to address situations involving children.
- 11. Focus on driving. Multi-tasking behind the wheel is dangerous. Refrain from eating, drinking, reading, grooming, smoking, and any other activity that takes your mind and eyes off the road.

#### Teenagers Are At The Most Risk! How Can Parents Help?

- > Talk to your teens.
- > Set clear "House Rules."
- ➤ Remind your teen that driving is a privilege a privilege they will lose if they don't drive by your rules.
- ➤ Be a good example—show responsible driving behaviors starting when your children are young.

## Request Your Siletz Tribal ID Card Today!

If you are <u>unable</u> to make it to the Administration building in Siletz to obtain or replace your Siletz Tribal ID card you are now able to request one at on of the three Area Offices; Eugene, Salem and Portland. They will take your photo and obtain your signature then send it to the Enrollment Department in Siletz. Your Tribal ID will then be mailed by CERTIFIED mail to your address on file or to the Area Office where you made your request.

If you have family that <u>do not</u> live in the 11-county service area or are not able to make it to a Tribal office during work hours, there is a form on the Tribal website under Government Listings > Enrollment and the tab marked "Enrollment Forms." Tribal members can print the form titled "Siletz Tribal Identification (ID) Request" and follow the directions regarding the digital photo specifications, identity verification and signature verification then mail the form to the Enrollment Department.

If you have not updated or replaced your Tribal ID card since April 1, 2016 there is a new format and more information on the card that makes it more acceptable as a form of identification with many more places. The expiration date is 10 years from the issue date. When you update your address, send in your Tribal ID card and we will mail you an updated card with your new address.



If you need to replace your card with no changes (for example address or name) within the same calendar year it was issued, there is a \$5.00 replacement fee (per Tribal Resolution #2016-087). You can obtain up to one new Tribal ID card per calendar year at no charge. Call the Enrollment Department at (800) 922-1399 ext. 1258 if you have questions about this fee.




## BULLS BAG FISH HABITAT RESTORATION PROJECT Meeting for Tribal Member Feedback

#### Elk Tag Opportunity

The Tribal Natural Resources Department will once again be offering a limited number of Landowner Preference (LOP) elk tags to Tribal members for this fall's hunting season. As a landowner, the Tribe is eligible to participate in the State's LOP program. Based on the number of acres that the Tribe owns, we can get 6 additional antlerless elk tags from the State. These LOP tags are not related to the Tribe's Consent Decree tags that we receive each year. They are based solely on the Tribe being a landowner.

There are a number of important differences between the LOP tags and the Tribe's regular tags. These are summarized in the table below.

* Note: If you are drawn for an LOP Tag you are still eligible to apply for and be drawn for a Tribal tag.				

Please note that a major difference between the LOP tags and the Tribe's regular tags is that ONLY the person drawn for the tag can hunt that tag. The tag cannot be given to someone else to hunt for you. Therefore, only those folks serious about hunting this hunt themselves are eligible to apply.

The drawing for the 6 LOP elk tags will be held at the Natural Resources Committee Meeting to be held on April 2<sup>nd</sup> at 4:45 PM in the Natural Resources Department Map Room. Applications are available on the Tribal website and at the Tribal Natural Resources Office in Siletz. Completed applications are due in the Natural Resources office by 4:30 PM March 30, 2018. ### **Tribal Stewards Program**









The Tribal Stewards Program is specifically designed to provide hands on training and experience to Native American young adults who are interested in pursuing employment with conservation corps, land and water resource management agencies, and other outdoor careers. The Tribal Stewards Program integrates team-based work projects, culture relevancy, education, and on-site vocational training into an experience that prioritizes personal growth, and the development of conservation work skills. Participants will develop technical skills working on a variety of conservation projects while developing the soft skills needed to be successful in the outdoor industry.

Tribal Stewards members spend 12 weeks camping, working and traveling together as a six person team. You can expect to work on physically challenging conservation projects in many kinds of weather, gaining hands on experience in the groundwork of stewardship. Each day, you will return to camp after work and participate in community activities, including meal prep, water collection and treatment, and tool maintenance, followed by a family style dinner. Evenings will be spent on various educational and recreational activities; including formal lessons taught by team members, group discussions, and stargazing around the campfire.

**2018 Dates:** June 18 to September 26

#### **Overview:**

- Projects take place with the Pacific Crest Trail Association in Mt. Jefferson Wilderness near Warm Springs, OR.

- Preheat oven to 350\*. Grease and flour, or parchment line 2 average size bread pans.
- Preheat ovento 350\*. Grease and flour, or parchment line 2 average size bread pans.
   In a large bowl, combine all the dry ingredients for the bread. Whisk together well.
   In another bowl, mix the egg powder and water, pumpkin, oil, and vanilla together. Mix the pumpkin mix ture into the flour mix ture. Combine will. Add the chopped apple and mix to combine. Do not beat with electric mixer, use a spoon.
   Make the filling. Mix all ingredients together in a bowl. It should resemble a paste.
   Divide half of the pumpkin batter between the two loaf pans. Divide the filling in half. Place spoonfuls of the filling more towards the center of the loaf avoiding the outside edges of the batter.

- Divide remaining batter. Top the filling with the remaining batter between the two pans. Gently spread evenly. Place in oven and bake one hour or until to oth pick inserted comes out clean. Cool and enjoy.



#### Bear Claws and Teeth Available

The Tribal Natural Resources Department periodically obtains bear parts from the Oregon Department of Fish and Wildlife for Siletz Tribal members to use in making regalia and ceremonial items. An effort to reduce the bear paw and snout parts to manageable size has been done by volunteers, but parts still have bone, fur and tissue attached. The final preparation of claws and teeth to create clean, useable items is the responsibility of the tribal member. Parts are kept frozen and are distributed on a firstcome-first-served basis as they become available. Bear parts may only be used by Siletz Tribal members and may not be traded or sold.
