The Elders Program will be stongly enforcing the following policy:

### Section: XI: Travel and Emergency Information

**B.** Elders that require a caregiver/family member to assist them in their homes for meals, medication supervision or their personal safety shall be required to have a caregiver/family member attend functions with them. This shall be **STRICTLY ENFORCED** when traveling overnight.

Necessary costs for the caregiver/family member to attend shall not be paid by the Elders Council. A "Caregiver Responsibilities" form must be complete and submitted to the Elders Staff prior to the trip.

Policy can be referenced in the Confederated Tribes of Siletz Indians Elders Council Rules of Procedures Section: XI: Travel and Emergency Information. Pages 12-13

Functions include, but are not limited to Elder events and activities, shopping days, Elders Council Meetings, Elders trips and overnight stays.

## Ingredients

Preparation time:

25 minutes

Cooking time:

35 minutes.

9 medium apples, peeled and sliced

1/4 cup plus 1/4 cup Splenda, No

Calorie Sweetener, granular

1/4 cup plus 1/4 cup sugar

2 teaspoons cinnamon

3/4 cup all-purpose flour

3/4 cup old-fashioned oatmeal

1/2 cup *trans-fat-free* margarine

## Directions

Yield:

15 servings

Serving size:

1/2 cup

Preheat oven to 375°F. Toss apples with 1/4 cup Splenda, 1/4 cup sugar, and cinnamon. Transfer apple mixture into a 9" x 13" baking pan. Beat margarine and add the remaining 1/4 cup Splenda and 1/4 cup sugar along with the flour and oatmeal. Blend until well mixed. Evenly distribute flour mixture over apples. Bake for 35-40 minutes on the top rack of the oven until topping is lightly browned and apples are soft.
