## **Confederated Tribes of Siletz Royalty Guidelines**

Siletz Royalty Court consists of winners of each category – Little Miss Siletz, Junior Miss Siletz and Miss Siletz.


Candidates must be enrolled Siletz Tribal Members.

Candidates must be single with no dependents.

Candidates for Miss Siletz must be between the ages 17-21, Junior Miss Siletz 12-16, Little Miss Siletz 7-11.

**These age requirements must be met by September 1<sup>st</sup>.**

1. If under the age of 18 you must have a Parent or Sponsor who will be able to help you attend designated organizational meetings, activities, parades, fundraisers and scheduled appearances.
2. Communication between Royalty contestants, sponsors/parents and Pow Wow Committee representatives and Staff will be conducted via email.
3. If you are unable to attend a required function you must submit a request in writing to either the Pow Wow Coordinator and/or Pow Wow Committee Royalty Representative with at least a weeks' notice unless in case of emergency.
4. You will be disqualified if you miss three scheduled events without cause and the runner-up will perform your duties for the remainder of the year.
5. You must be drug, alcohol and tobacco free; any misconduct will result in disqualification from you position.
6. If at any time you become pregnant you will be disqualified from your position.
7. You are required to have complete regalia (Traditional, Fancy or Jingle).
8. You must have a willingness to dance at all Pow Wows and cooperate in all scheduled events (assistance with dance instruction can be provided if needed). Royalty is expected to remain fully dressed down with crowns on from Grand Entry to Retiring of the Colors.
9. You must be willing to speak in public.
10. You must be willing by your behavior to represent the Siletz Tribe in the best possible manner.
11. You are expected to show good judgment and not participate in activities that would bring adverse publicity to yourself or the Siletz Tribe while you hold your title.
12. When attending a scheduled function, all royalty need to be in appropriate attire/regalia, Traditional or Modern. The following is not considered appropriate attire:
  - a. Mini skirts
  - b. Bare mid-drifts
  - c. Spaghetti strap tops (unless covered with jacket, sweater, etc.)
  - d. Low cut shirts
  - e. Heavy make up
  - f. Visible body piercings other than in the ears must be removed while attending required events.



g. Visible tattoos must be covered while attending required events with the exception being traditional Siletz Tribal tattoos i.e. 111's.

13. You must be conscientious of your conduct, language, pictures and posts on social media networks (Facebook, Instagram, Snapchat, TikTok etc.).
14. Consequences for misconduct will include but not be limited to verbal warnings, written warnings, reduction or suspension of mileage reimbursement for 3 events, reduction or suspension of out of state travel paid for and in severe cases removal of title and crown permanently. The Pow Wow Committee reserves the right to discuss and administer discipline depending on severity.
15. The above guidelines apply to each candidate. If not honored you will be disqualified from your position and forfeit any title and crown won.
16. There may be other requirements not mentioned in these guidelines. If other requirements are imposed on Royalty you will be notified in advance and will be required to follow them.
17. Should circumstances arrive that would prevent a contest for the Royalty Court, the Pow-Wow committee may ask current Royalty Court members to continue on for another year and retain the title won during the last royalty contest.
18. Use of foul language, bullying, verbal abuse, harassment, intimidation by contestants, sponsors, parents, family members or friends against staff members, committee members, judges, fellow contestants and their family/sponsors or community members will not be tolerated in any form and could result in dismissal from competing for royalty or dismissal from royalty court.
